1. SUBMISSION OF TENDERS

Tenders will be opened in public immediately after the advertised closing date. Submissions must be in a sealed envelope clearly endorsed as per instruction on page 5 of the tender document (advert).

2. TENDER DEPOSIT

3. ADJUDICATION OF TENDER

The City of Mbombela will not be bound to accept the lowest or any tender and also reserves the right to cancel the tender when deemed necessary.

The tender will be adjudicated by the City of Mbombela in terms of the Preferential Procurement Policy Framework Act, no. 5 of 2000 and as defined in the conditions of bid in the bid document, read in conjunction with the preferential procurement regulations, 2017, where 80 points will be allocated in respect of price and 20 points in respect of B-BBEE status level of contribution.

4. COMPLETION OF TENDER DOCUMENTS

6. TAXES AND DUTIES PAYABLE

SPECIFICATIONS/ TERMS OF REFERENCE & SCOPE OF WORK

1. BACKGROUND

In the Revenue Enhancement Strategy of the Municipality the issue with regard to the management of all outdoor advertising contracts was raised as a potential increased revenue stream for the municipality.

The intension is to appoint a service provider on risk to evaluate and manage all outdoor advertising contracts and outdoor advertising opportunities on behalf of Council with the aim to create sustainable increased revenue for the municipality while providing maximum opportunity for commercial advertising space.

2. OBJECTIVES

The functions that will be expected to be delivered to the City, by the successful bidder, shall be the following:

- To assess the full spectrum of the current outdoor advertising structures and opportunities in the City on Council owned properties;
- To conduct a due diligence of the full spectrum of current outdoor advertising developed in the City;
- To do a legal due diligence of the full spectrum of current outdoor advertising developed in the City;
- To do a financial due diligence of the full spectrum of current outdoor advertising developed in the City;
- To advise the City on a strategic vision for the full spectrum of the outdoor advertising industry in the City, in line with the best practices in the industry in the world;
- Managing the full spectrum of the above process on behalf of the City in its entirety.

3. SCOPE OF WORK

The scope of work expected include inter alia:

- 3.1 Industry and trends analysis to determine best practice;
- 3.2 Audit of all existing Outdoor Advertising Infrastructure located on municipal owned properties;
- 3.3 Comprehensive assessment of all existing Outdoor Advertising contracts;
- 3.4 Do due diligence (i.e. financial and legal) of all Outdoor Advertising contracts;
- 3.5 Advise the City on the Strategic Vision for Outdoor Advertising within the municipal area;
- 3.6 Assist the City to increase revenue on all existing Outdoor Advertising contracts;
- 3.7 Assist the City to identify further opportunities with regard to Outdoor Advertising.

4. NECESSARY SKILLS AND EXPERIENCE

The service provider will comprise of a multi-disciplinary team and the members of the team will have both the skill and experience necessary to undertake the range of tasks set out in these terms of reference. Each individual on the team must be personally available to do the work as and when required. The lead consultant will be held accountable for ensuring project deliverables and for the professional conduct and integrity of the team.

- Legal, with relevant experience in contract law;
- Financial, with regard to financial due diligence and feasibility;
- Contract management;
- Outdoor Advertising and Marketing Expert.

 - c) cancel a contract awarded to a person if the person committed any corrupt or fraudulent act during the bidding process or the execution of the contract.
- 4 This MBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.
