3. ADJUDICATION OF TENDER

The City of Mbombela will not be bound to accept the lowest or any tender and also reserves the right to cancel the tender when deemed necessary.

The tender will be adjudicated by the City of Mbombela in terms of the Preferential Procurement Policy Framework Act, no. 5 of 2000 and as defined in the conditions of bid in the bid document, read in conjunction with the preferential procurement regulations, 2017, where 80 points will be allocated in respect of price and 20 points in respect of B-BBEE status level of contribution.

1. GENERAL INFORMATION

BACKGROUND

City of Mbombela is the registered owner of several properties situated within its boundaries i.e. (Central, Eastern and Southern Regions) and amongst those properties some are portions of vacant land zoned as (i.e. residential, parks and business development). The Municipality is currently leasing out those vacant portions to various Telecommunications service providers such as Vodacom, MTN and Cell C for the purpose of erecting cell phone masts.

PURPOSE /OBJECTIVE OF THE PROJECT

To appoint a registered service provider to offer service management and contract evaluation of Telecommunications Towers within the City of Mbombela for a period of three (3) years contract on risk basis,

2. SCOPE OF WORK

The successful candidate/company will be responsible for;

- Auditing of all cell phone towers infrastructure within the City of Mbombela
- Ensure comprehensive assessment of all leases/contracts
- Ensure due diligence of all cell phone masts i.e. (Legal & financial)
- Advise City of Mbombela of future strategic vision
- Assist the City to generate and increase revenue through rental income from leasing out of portions of land
- The recommended and approved service provider will provide his or her labour, materials and tools for the duration of the project,
- The successful service provider will be expected to sign a performance contract with Council to ensure that professional standards are adhered too.
- The service provider will be expected to stick to project deadline

3. Evaluation criteria

Quality/Functionality will be used as an evaluation criterion, but not for the purposes of points in terms of the 8 point system. Only those bids that fully comply with quality (responsive bids) will proceed to the scoring for price and preferences.

The minimum point to be scored for functionality/quality should be equal to 75%, in order to be considered for further evaluation. **Failing to score the minimum required points will lead to immediate disqualification.**

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
