#### SPECIAL CONDITIONS OF THE BID

#### 1. SUBMISSION OF TENDERS

The tender is to be made out on the tender form attached hereto, which must not be detached from this document, and the completed document, fully priced, extended and totalled, completed in all respects, signed and is to be sealed in an envelope which is to be enclosed and delivered in accordance with the instructions contained on the Invitation to Tender.

Proof of posting of a tender will not be accepted as proof of delivery to the appropriate place for the receipt of tender.

Tenders will be opened in public immediately after the advertised closing date.

The information to be submitted by prospective bidders will only be used for tender purposes taking into consideration the Protection of Personal Information Act (POPI Act).

#### 2. TENDER DEPOSIT

#### 3. ADJUDICATION OF TENDER

The City of Mbombela will not be bound to accept the lowest or any tender and also reserves the right to cancel the tender when deemed necessary.

The tender will be adjudicated by City of Mbombela in terms of the Preferential Procurement Policy Framework Act, no. 5 of 2000 and as defined in the conditions of bid in the bid document, read in conjunction with the preferential procurement regulations, 2022, where 80 points will be allocated in respect of price and 20 points in respect of targeted goals.

Prospective service providers may not make any alterations or additions to the Bid document, except to comply with instructions issued by the employer. The tender document must be furnished with non-erasable black ink and all corrections made by the service provider should be dated and signed by the authorised signatory. Erasures and the use of masking fluid, tippex, pencil or erasable ink are prohibited and failure to adhere to this condition will render your submission non responsive.

Certified copy of B-BBEE Certificate OR Original Sworn Affidavit for B-BBEE / certified copy of a Sworn Affidavit for B-BBEE. Failure to adhere will lead in non-claiming on preferential points.

A bid not complying with the mandatory requirements stated in the bid document will be regarded as non-responsive and as such will be rejected. If a Bid has not been properly signed by a party having the authority to do so, according to the example of "Authority for Signatory" will be rejected. This condition will not apply to companies owned by one director / member / sole proprietorship.

A bid will be rejected if any municipal rates and taxes or municipal service charges owed by the bidder or any of its directors to the municipality, or to any other municipality or municipal entity, are in arrears for more than three months. Similarly, none submission of proof of valid and up-to-date rates and taxes statement will render the submission non-responsive.

Bids will be rejected if the bidders or any of the directors are listed on the Register of Bid Defaulters in terms of the Prevention and Combating of Corrupt Activities Act of 2004 as a person prohibited from doing business with the public sector. Bids will be rejected if the bidder has abused the CoM's Supply Chain Management System or SCM Processes of any state institutions.

#### 4. COMPLETION OF TENDER DOCUMENTS

Tenders will only be considered on receipt of this tender document correctly completed with all insertions in black ink and signed.

The following compulsory documentation **MUST** be attached in order for the bid to be considered:

- Company registration certificate
- Copy of a valid Tax Compliance Status (TCS)
- Company profile with CV's of key personnel
- Proof of company registration
- CSD full registration report must **NOT** be older than **30 days** from closing date and summary report will NOT be considered)
- Tenderer must provide valid copy of municipal rates and taxes for both the company and for the active directors including JV/Consortium partners, Copies of latest municipal rates and taxes certificates from relevant local authority / proof of residential from tribal authority (if the business is operating or the directors are residing in rural areas) / lease agreement with the lessor's up-to-date municipal rates and taxes for both the business and all business directors. Prospective bidders should ensure that the physical address details of the company and directors reflected on the CSD is similar to the one reflected on the company registration certificate. The municipality reserves the right to verify both the municipal rates and taxes of the company details reflected on the CSD and company registration certificates. The municipality further reserves the right to use ID numbers of the directors to verify if any municipal rates and taxes are not owned by each director. It is prudent and remains the responsibilities of the prospective bidders to ensure that each director, lessor and company rates are cleared with regards to the municipal rates and taxes.
- NB: Certified copies of documentation must not be older than three months to be regarded as valid. Copies of "certified copies" will not be acceptable as true copies of original documents. Failure to adhere will lead to immediate disqualification.

#### 5. COMPULSORY BRIEFING SESSION

A compulsory briefing session will be held at 1 Nel Street, Mbombela Civic Centre on 4 October 2023 at Nelspruit Civic Centre Hall at 12:00.

#### 6. WITHDRAWAL OF TENDER

In the event of the awarded bidder fails to execute the services in terms of this tender, the Municipality shall be entitled to cancel the contract summarily, in which event the Bidder shall be liable for any additional expense incurred by reason of the Municipality having to call for fresh tenders or having to accept any less favourable tender. The Municipality will without prejudice consider listing the service provider in the National Treasury restricted bidders register.

#### 7. NOTICE OF BIDDERS

Should any additions or alterations to the document as issued to Bidders be deemed necessary prior to the date for submission of tenders, these will be issued to Bidders in the form of Notices to Bidders and will form part of the tender document.

The Notices to Bidders shall be completed where applicable by Bidders, signed, dated and returned with the tender documents.

#### 8. PERIOD OF VALIDITY OF TENDERS

The bids submitted by the service providers will be valid for a period of hundred and twenty (120) days and the validity period may be extended for further period of thirty (30) days. The following procedures and processes shall be followed in extension of the validity date.

- (a) Requests for the extension of validity dates must be extended to all service providers.
- (b) Proof should be provided that all services providers shown interests in the bid have been contacted.
- (c) Service providers have consented on the extension.
- (d) Bidders that have not responded or rejected the request for the extension of the validity will be eliminated from the processes.
- (e) That any prices changes resulting from the extension of the validity date shall be taken into considerations when evaluating bids.
- (f) The request for the extension for the validity date extended to interested service providers shall have a (seven) 7 working dates respond period.
- (g) Every case will be treated on its own merit, however, non-response from the services providers does not render the entire project null and void.

#### 9. TAXES AND DUTIES PAYABLE

Bidders shall allow in their tender for the payment and recovery of all taxes and other duties. No claims for additional payment in this respect will be considered. Prices and rates quoted shall be inclusive of Value Added Tax (VAT). VAT shall be recorded as a lump sum in the tender summary and the total inclusive of VAT carried to the Form of Tender.

#### 10. BID PRICE

This project has no pricing schedule and it will be evaluated at a technical level only. Successful bidders will be pre-approved and put in a database to be utilized on an ad-hoc bases. The sourcing of services will based on RFQs where 80/20 principle shall apply. Bidders will be expected to price within the legislated fees and price offer above the legislated fees will not be accepted.

# TERMS OF REFERENCE PANEL OF PROFESSIONAL SERVICE PROVIDERS; LAND SURVEYOR'S TO BE APPOINTED IN THE CITY OF MBOMBELA FOR THE PERIOD OF THREE (3) YEARS

#### 1. BACKGROUND

The City of Mbombela requires, from time to time, external assistance to complement its current capacity in order to fulfil its obligations in terms of the MFMA. Most of the assistance is required at short notice and it is therefore the intention of the Municipality to compile a list of experienced and competent service providers in the various fields of Land Surveying. The qualifying service providers will be listed on a pre-approved panel of service providers. When a need is identified for external support, the municipality will develop detailed terms of reference and request all service providers in the field of the required expertise to submit a comprehensive proposal to execute the terms of reference. These proposals will then be evaluated, and the best service provider will be considered for appointment through the SCM committee system.

#### 2. SCOPE OF WORK

The following categories of services have been identified as the Scope of Work to be performed during the financial years 2023/24 to 2025/26. These are considered the main areas of focus and are not intended to be exhaustive. Bidders need to demonstrate, through their proposals and previous experience, their capabilities in undertaking assignments in the following categories of service and completing them satisfactorily.

#### 2.1. Land Surveying

- Activities:
- Gather all required base mapping information required as part of topographic survey
- Generate contour map to meet the engineering requirements
- Number the final layout plan for town planning purposes
- Carry out pegging and calculation of co-ordinates
- Obtain erf numbers from Surveyor General (SG) Office
- Prepare township general plan for registration for submission to the SG
- Obtain approved SG plans
- Site Verification
- Issuing trig-beacon certificate
- Any other activities identified by the Municipality

#### 2.2. Formalisation and Township Establishment

- Identify the Existing demarcation of each Stand/area, in conjunction with the Municipality.
- Detailed topographic surveys for the purpose of developing a Contour Map

- Geo-referenced survey of the identified settlement/s, for Formalization:
  - Topographical features and contours.
  - Existing structures and boundary
  - Existing infrastructure.
  - Public spaces and places.
- Consultation with stakeholders on the layout plan
- Produce the delineation of stands and coordinates.
- Produce surveyed layout plans.
- Propose areas for bulk infrastructure servitudes.
- Preparation of final layout for submission to the Municipality.
- Establish a Geo-database

#### 2.3. Pegging of Stands and General Plan Submission

#### Activities:

- Carry out pegging and calculation of co-ordinates
- Prepare a draft General Plan.
- Submission of the Draft General Plan to the Surveyor General within the stated legislated timeframes.
- Apply for extension of township periods when necessary.

#### 2.4. Lodgment of Documentations with Deeds Office

- Compliance with all the pre-proclamation conditions.
- Compliance Certificate by the Municipality
- Registration of any servitudes constructed in with Deeds Office
- Opening of Township Register
- Proclamation of an Approved Township

The service providers will be required to sign specific agreements for individual projects. The approved list of service providers must have the capacity, functional skills and experience, to provide the services required at a level acceptable to the City of Mbombela.

#### CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids<sup>1</sup> invited.
