FINANCIAL YEAR 2016/17

All applications for a rebate on property rates for a financial year should be in before 30 October 2015 to qualify for a backdated rebate. Applications received after end of October will qualify for a rebate as from date of application. To qualify for retiree/ pensioners and/or disabled person rebate the following conditions must be complied with:

- (a) Must not own more than one property;
- (b) be at least 60 years of age; (Attach proof)
- (c) total household income of less than **R172188.00** per annum or **R 14349.00**per month (Attach proof)
- (d) If the total household income is more than **R154775.00** per annum and/or **R 12897.92** per month please indicate.

The effective date of the rebate will be the date when the Municipality approves the application, irrespective of whether the property qualified for exemption in terms of its use prior to that date.
