FOR THE 2026/2027 FINANCIAL YEAR**



CHARGES FOR SANITARY AND REFUSE (SOLID WASTES) REMOVAL

The City of Mbombela hereby gives notice in terms of Section 75 of the Local Government Municipal Systems Act, 32 of 2000 (as amended), that the following tariffs, fees, and charges applicable to the Sanitary and Refuse Removal By-laws, have been determined and accepted by Council with a unanimous decision under Item A (3) during a Special Council meeting held on 29 May 2026.

The determinations shall come into effect on 1 July 2026.

DEFINITIONS:

"Removal" means the removal as indicated from residential, business, commercial or industrial property;

"Liner" means plastic refuse bag not exceeding 0,1m³;

"Owner" means a person as defined in the Municipal Property Rates Act, Act 6 of 2004, and the Local Government Systems Act, Act 32 of 2000;

"Property" as defined in the Local Government Systems Act, Act 32 of 2000, and the Municipal Property Rates Act, Act 6 of 2004.

NOTE:

The City of Mbombela is in the process of standardizing the tariffs. Certain tariffs will phase in immediately because the same containers are used and the same service is rendered.

1. REFUSE

1.1 DOMESTIC REFUSE

For a maximum of 5 plastic bin liners, liners not exceeding 0,1m³ capacity, per removal and where a service is rendered once per week, per month, or part thereof:

(a)	From residential property in Nelspruit, White River, and Hazyview where a service for the removal of domestic and garden refuse is rendered by the Municipality	R 299.22
(b)	From residential property in areas where a service for the removal of domestic, sanitary and garden refuse is rendered by a contractor	R 198.81
(c)	From property on which flats are erected in Nelspruit, White River, and Hazyview, where a service for the removal of domestic refuse is rendered by the Municipality, per flat	R 248.88
(d)	From residential property in Kabokweni where a full service is rendered	R 211.68
(e)	From residential property in Kabokweni where a partial service is rendered	R 132.72
(f)	From residential property in Umjindi where a service for the removal of domestic and garden refuse is rendered by the Municipality	R 255.34

The monthly charge applicable shall apply to all properties, vacant, developed or unoccupied included, in a serviced area.

Provided that:

No basic or minimum charge will be payable on an erf, stand, lot or other area purchased from the City of Mbombela on condition that the stand must be consolidated with an adjoining property or properties.

5. GENERAL

The owner of premises where the Municipality is rendering waste services contemplated in the Solid Waste Management Bylaw, (Provincial Gazette No 3995 dated 26 June 2026), is liable for payment of the prescribed tariffs due to non-usage, partial or limited use of such services. The Municipality shall

charge the applicable tariffs on or from date of the certificate of occupation.

6. INTEREST RATE

The interest rate on amounts in arrears on all services shall be determined for each financial year and calculated on the basis of the prime lending rate applicable at 30 June of each year as determined by the South African Reserve Bank plus 1 % fixed for the ensuing 12 months of the financial year.

7. VALUE ADDED TAX

The tariffs do **NOT** include VAT (Value Added Tax).
